## BEYOND BRICS: A NEW ERA FOR THE GLOBAL SOUTH? PERSPECTIVES FROM SOUTH AFRICA AND INDIA

Date: April 24th, 2024

Panelists: Professor. (Dr.) Hebatallah Adam, Acting High Commissioner of the Republic of South Africa to India, His Excellency Cedric C. Cowley and Ambassador (Retd.) Rajiv Bhatia.

The panel discussion, "Beyond BRICS: A New Era for the Global South? Perspectives from South Africa and India," was held by the Jindal Centre for the Global South in collaboration with the Jindal India Institute on April 24, 2024. Moderated by Dr Hebatallah Adam, the panel featured his excellency Cedric C. Cowley, Acting High Commissioner of South Africa to India, and Ambassador (Retd.) Rajiv Bhatia. Attendees included Dr. Sreeram S. Chaulia, Dean of the Jindal School of International Affairs, JGU professors, High Commission staff, Jindal Centre members, and JGU students.

Dr. Chaulia's opening address emphasized the panel's focus on the Global South's challenges and the need for collaboration and inclusivity to achieve national goals. H.E. Cowley noted that competitiveness and polarization are shaping inter-state relations, suggesting the evolution of international organizations to address these issues. Ambassador Bhatia highlighted BRICS as a counter-narrative to the G7's dominance and praised its expanding membership and collaboration between India and South Africa.

The discussion also advocated for a "UN 2.0," stressing interconnected global prosperity and South Africa's journey from BRICS invitee to member. Attendees contributed insights on decolonized learning and knowledge-sharing to strengthen BRICS. As a fortunate matter of symbolism, the panel coincided with the 69th anniversary of the Bandung Conference. The event concluded with a focus on shared prosperity and Global South solidarity, followed by a felicitation ceremony.

#### **BOOK TALK - "ARAB SPRING THAT WAS AND WASN'T"**




Panelists: Prof. (Dr.) Sreeram Sundar Chaulia, Prof. (Dr.) Abdul Fattah Ammourah, Ambassador K.P. Fabian

The Jindal School for Global South hosted a compelling panel discussion on Ambassador K.P. Fabian's book, "Arab Spring That Was and Wasn't." Prof. (Dr.) Sreeram Sundar Chaulia initiated the event, praising Fabian's work and summarizing the book's exploration of the Arab Spring's origins. He highlighted the roles of various national and international actors and noted that some post-revolution conditions, such as in Libya, are now worse than before. Prof. Chaulia critiqued the book and encouraged a multi-faceted analysis of the Arab Spring, rebranding it as the 'Dignity Revolution.'

Prof. (Dr.) Abdul Fattah Ammourah offered a provocative perspective, questioning the true intentions behind the uprising. He described the dire situation in Syria and argued that West Asian regimes are manipulated by the Western Hegemonic World Order, presenting the Syrian war as a proxy conflict. He called for increased Arab solidarity to regain control over their own resources and destiny.

Ambassador K.P. Fabian concluded the discussion by clarifying the true nature of the Arab Spring revolts. He criticized the Orientalist view of democracy associated with the uprisings, which he believes undermines genuine democracy in the region. Fabian passionately recounted the uprisings in Tunisia, Syria, Libya, Yemen, and Algeria, exposing global leaders' vested interests. He differentiated various decolonization processes and concluded by advocating for a more nuanced critique of the supposed conflict between democracy, modernity, and Islam, emphasizing that humanity's diversity transcends any single race or religion.



## GUEST LECTURE: SOCIAL PROTECTION REFORM IN ARAB COUNTRIES

JINDAL CENTRE FOR THE GLOBAL SOUTH

On September 6, 2023, O.P. Jindal Global University hosted a guest lecture on 'Social Protection Reform in Arab Countries,' organized by the Jindal Centre for the Global South. The event featured Ms. Gisela Nauk, Senior Social Affairs Officer at the UN Economic and Social Commission for Western Asia, and was moderated by Dr. Hebatallah Adam, Director of the Jindal Centre for the Global South.

Ms. Nauk discussed the evolution and challenges of social protection systems in the Arab world, highlighting their critical role amid socio-political upheavals. She outlined the three main functions of social policy: managing individual risks, stabilizing economic conditions, and fostering social cohesion. Ms. Nauk noted that post-Arab Spring, Arab countries shifted focus from economic growth to social protection, as traditional development indicators proved inadequate. This led to the adoption of alternative metrics like the Human Development Index (HDI) and Sustainable Development Goals (SDGs), transitioning from subsidies to cash transfers.

#### Key lecture points included:

- Social policy's role in resilience, equality, cohesion, and stability.
- The shift to new metrics post-Arab Spring, such as HDI.
- Implementation challenges, particularly for the informal sector.
- The "missing middle" affected by subsidy removals without social insurance.
- Innovative approaches like Saudi Arabia's minimum income program, blending assistance and insurance.

The lecture underscored the complexity of social protection reform and advocated for policies that uphold human rights and promote resilience.













# GUEST LECTURE: CLIMATE CHANGE AND SUSTAINABILITY CONCERNS IN AFRICA

Panelists: Professor. (Dr.) Hebatallah Adam, Ms. Chizoba Mzeakor, Dr. Chisom Ubabukoh

Ms. Chizoba Nzeakor, a climate champion and CEO of Climate Tech Solutions and Zoba Advisory, was honored with the African SDG Achievers Award in 2023. In her lecture, "Climate Change and Sustainability Concerns in Africa," she emphasized the urgent need to address climate change.

Although Africa contributes only 7.2% of global greenhouse gas emissions, it faces severe impacts such as flash floods and droughts in Nigeria and Kenya. Ms. Nzeakor highlighted global initiatives like the Paris Agreement and discussed the consequences of climate change, including rising sea levels and extreme weather.

She advocated for sustainability and the transition from fossil fuels to renewable energy sources, such as solar, hydro, and geothermal. Renewable energy offers job creation and energy security, with Africa's significant solar potential being particularly noteworthy. She also stressed the importance of efficient energy use, infrastructure upgrades, and smart grids.

Policy regulation is crucial, yet African policies often encounter bottlenecks. Effective policies, like carbon pricing and emission reduction targets, are essential. Ms. Nzeakor also discussed the need for clean transportation, citing examples from Switzerland and the Netherlands, and emphasized grassroots education for adopting electric buses and trains.

She highlighted the role of businesses in the net-zero transition and the importance of funding and investments in clean energy. Public awareness and behavior change, including education campaigns, are vital. Collaboration among governments, businesses, civil society, and youth is essential for a just transition. Dr. Chisom Ubabukoh from Jindal Global Law School added that Africa's climate impact and conservation funding disparities necessitate social welfare policies for vulnerable communities. The event underscored the need for collaborative global action and individual responsibility in promoting climate consciousness, in line with the UN SDGs.

# MAKING SOUTH-SOUTH COOPERATION WORK FOR AFRICA - CHALLENGES AND OPPORTUNITIES FOR THE AFRICAN UNION AS A MEMBER OF THE G20



Prof (Dr) Hebatallah Adam participated in the Jindal Global Centre for G20 Studies and the Asia Foundation's conference on "Making South-South Cooperation Work for Africa - Challenges and Opportunities for the African Union as a member of the G20." which took place on Friday, October 20, 2023, at the Hotel Taj Mahal in New Delhi.

She presented to the panelists her views on Africa's development and finance challenges and opportunities during the second session, which was brilliantly moderated by Ms. Nandita Baruah, Country Representative – India, The Asia Foundation. Ambassador (retd) Shri Rajiv Bhatia, Distinguished Fellow, Foreign Policy Studies, joined the discourse as a panelist, making the discussion even more enriching and informative.

Appreciation to Ambassador Mohan Kumar and his dedicated team at the Jindal Global Centre for G20 Studies was also doled out by Prof (Dr) Adams, for their devoted inspirational and participation. The Asia Foundation Team was also thanked and held in esteem for organizing the significant event in a timely manner.



#### CII INDIA NORDIC BALTIC BUSINESS CONCLAVE





A 25-member delegation from the Jindal Centre for the Global South was invited to participate in the 2nd Edition of the India Nordic Baltic Business Conclave 2023 organized in New Delhi. The initiative was in collaboration with the MEA, and GOI, and aimed to foster increased partnership between India and the Nordic-Baltic Eight (NB8) (Denmark, Estonia, Finland, Iceland, Latvia, Lithuania, Norway, and Sweden) countries, known for their prowess in innovation and technology.

The conclave was strategically designed to facilitate dialogue among diverse stakeholders, recognizing India's pursuit of greater market knowledge, specific procedures, and compliance norms, which can be leveraged through the expertise of the NB8 region. Thus, the conclave aimed to bridge these knowledge gaps, offering a platform for information exchange that benefits both Indian businesses and their Nordic Baltic counterparts. It also provided vast opportunities for Indian industries to form partnerships and joint ventures, as well as enter into technology transfer agreements with institutions and enterprises in the NB8 region.

Students had the opportunity to participate in roundtable discussions and interact with Ambassadors and Business Leaders from the NB8 belt, engaging in insightful roundtable discussions with NB8 ambassadors and Business Leaders from different corporations (IKEA, Infosys, etc.)

The discussions were focused on exchanging ideas and forging novice partnerships that will drive sustainable development and growth across the globe.

Jindal Centre for the Global South acquired the privilege of organizing a book discussion on "Political Economy of Development in the Global South Post-Covid 19 pandemic" by Prof Hebatallah Adam associate professor and director JCGS, (co-editor Prof. Rena) that was published by Springer. The program was scheduled for the 17th of January 2024.

JCGS was honoured to host Ambassador Gurjit Singh, Former Indian Diplomat, Ambassador of India to Germany, Indonesia, ASEAN, Ethiopia, and the African Union; along with Prof. V. Upadhyay, Former Professor, Head of, the Department of Humanities and Social Sciences, IIT Delhi, and the S K Dey Chair Professor ISS, New Delhi, as Panelists at the discussion.

The discussion was launched by Prof. (DR) Hebatallah Adam, Director of JCGS.

The session was moderated by Dr. Chisom Ubabukoh, Ph.D., Assistant Professor (Economics) at Jindal Global Law School (JGLS) & Associate Fellow of the Higher Education Academy (AFHEA), at O.P Jindal Global University.







#### INTRODUCED 'SOUTHSIGHT' - ILLUMINATING THE GLOBAL SOUTH



The month of February 2024 was an exciting one for JCGS, due to the launch of 'SouthSight', JCGS's latest venture which promises to be a dynamic platform committed to shedding light on the multifaceted tapestry of issues, events, and achievements shaping the Global South. Unveiling the unseen, 'SouthSight' aims to present engaging segments such as illuminating explainers, riveting Global South facts, meticulously compiled news, insightful podcasts, sharp and informative infographics, interesting video content, and exclusive interviews.

JCGS further presented its first SouthSight explainer on the ICJ 'Genocide' Case brought up by South Africa against Israel. The author, Riddhi Deokar, a Research Intern at the center, dissected the Case, the Verdict, and its larger implications for the Global South. The recent case by South Africa against Israel in the International Court of Justice, accusing the latter of genocide reveals the strenuous history of the Israel-Palestine conflict which has ramifications not only for the players involved in the conflict but also for the larger world order. The Global South is no longer an "afterthought" when it comes to considerations regarding world issues and hence it is pertinent to understand how it plays into this conflict. Along with being a flagbearer of peace and conflict resolution, the Global South is diversely affected by the conflict. This engaging piece discovers the intricacies of the conflict, decoding the verdict and the ramifications it holds for the Global South and its role in the conflict.



#### RESEARCH EXHIBIT AS PART OF SAMVAAD



The JSIA Student Council and Diplomania organized the 'Samvaad' Conclave on the 12th and 13th of February, to heighten the vigor related to International Relations. This task was accomplished by choosing the integral theme, 'Globalization: The Way Forward'.

Hence, JCGS was glad to participate and showcase its research in connection to the theme, alongside various other JSIA Research Centers at a special exhibit set up for the purpose. On Day One, the JCGS Centre Coordinator Sarthak Mukherjee, alongside Riddhi Deokar, a research intern, showcased the center's work to Ambassador Sujan R. 

# INDIA'S G-20 PRESIDENCY – EFFORTS IN THE REDUCTION OF THE GLOBAL NORTH & GLOBAL SOUTH DIVIDE

India's G-20 leadership, encapsulated in the summit theme "Vasudhaiva Kutumbakam" or "One Earth, One Family, One Future," highlighted interconnectedness and inclusivity. The summit, hosted across 60 cities with over a crore participants, showcased India's cultural richness and commitment to decentralization. Prime Minister Narendra Modi termed it the 'People's Presidency,' emphasizing nationwide participation beyond the capital.

The September 9-10, 2023 summit underscored India's efforts to bridge the Global North-South divide. PM Modi emphasized support for Global South countries, highlighting development and climate initiatives such as the Global Biofuels Alliance and Green Hydrogen Innovation Centre. The Digital Public Infrastructure model aimed to bridge the digital divide in developing countries, while the focus on women-led development marked a narrative shift.

Key achievements included the Green Development Pact and the G20 Satellite Mission for Environment and Climate Observation, which aimed to share climate data globally. Efforts to reform Multilateral Development Banks focused on providing long-term financing for developing nations. Initiatives like Global Skill Mapping and Holistic Health and Wellness systems benefited the global community, reflecting the summit's theme.

India's leadership culminated in the unanimous approval of the G20 New Delhi Declaration, integrating perspectives from the Global South through the Voice of Global South Summit. The inclusion of the African Union as a permanent G20 member exemplified India's commitment to inclusivity, making "Incredible India" a fitting moniker for the host nation.

# FEMINIST ART IN THE GLOBAL SOUTH: USE OF CREATIVE MEDIUMS IN EXPANDING RIGHTS

During the 1980s, the art world in the United States experienced a covert revolution led by the Guerrilla Girls, anonymous feminist artists who exposed gender bias and sexism. Their provocative art and installations sparked a global movement, inspiring artists and activists to use creativity for resistance and advocacy. This wave of artistic activism resonated globally, especially in the Global South. In India, the 'Gulabi Gang,' led by Sampat Pal Devi, used theatrical street performances to combat domestic violence and caste discrimination. In Mexico, the 'Mujeres en Resistencia' highlighted gender-based violence and femicide through street art, murals, and performance art, showcasing the power of art to critique societal norms.

Artists such as Frida Kahlo, Chimamanda Ngozi Adichie, and Shirin Neshat address issues of gender, identity, and social justice through their work, incorporating local symbols and cultural contexts to raise awareness about marginalized voices. Movements like the 'Bring Back Our Girls' campaign in Nigeria and Pakistan's Women's Action Forum (WAF) illustrate the intersectionality of feminist art with broader social justice causes, including indigenous rights, LGBTQ+ rights, and environmentalism.

# FROM PIGGY BANKS TO INVESTMENT PORTFOLIOS: HOW PARENTS CAN SHAPE THEIR CHILDREN'S RELATIONSHIP WITH MONEY

#### **EGYPT'S ACTIONS TOWARDS CLIMATE CHANGE**

Egypt is highly vulnerable to climate change, facing heat waves, dust storms, rising sea levels, droughts, and water scarcity. The Nile River is particularly threatened by sea level rise, prompting initiatives like 'Egypt Vision 2030' and the 'National Climate Change Strategy 2050' (NCCS). Egypt was among the first to address climate change threats under the 'equity principle of common' in 1994. Key challenges include water scarcity, impacting agriculture and overall livelihood. The 'State of the Climate in Africa 2019 Report' highlights increasing threats to health, food, and water security. Over 95% of Egypt's water originates outside its borders, exacerbating the crisis due to its growing population and limited resources. To combat these issues, the U.S. is collaborating with Egypt. The 'Egypt Vision 2030' aims for sustainable development, energy access, and environmental protection, while the NCCS 2050 focuses on economic growth, resilience, governance, climate financing, and scientific research. Egypt's efforts are crucial, yet international collaboration is essential for broader climate change mitigation and adaptation.

# DIGITAL RENAISSANCE: UNVEILING THE DEVELOPMENT DISCOURSE IN THE GLOBAL SOUTH



This blending of traditional and modern elements reflects the ongoing negotiation of cultural identity in the Global South, where historical traditions intersect with global influences.



#### 3. Untitled" by Ibrahim Mahama (Ghana)



#### 1. Things Fall Apart" by Chinua Achebe



# 2. The Darker Nations: A People's History of the Third World" by Vijay Prashad


Synopsis - The book offers a critical perspective on the political agency and aspirations of formerly colonized nations, asserting their rightful place in shaping the course of modern history and challenging


